Advance Youth/Corporate Youth Invitational Qualifications & Requirements:

1. High School Students or member of a bona fide youth organization who is under the age of 18 as of January 1st, 2010 and older than 15 by January 1st, 2010.
2. Each youth must submit a parental consent and personal waiver.
3. Youths are **required** to have a valid photo ID with their date of birth on it. If the date of birth is missing from the photo ID, then the burden of proof is upon the individual.
4. Team must be supervised by authorized teacher/chaperon
5. There is a **minimum of four female** paddlers per youth team.
6. *Teams must be entered by one of our sponsors.
7. *Team must wear the uniform/T-shirt provided by the sponsor with sponsor's logo on one side and the high school/youth organization's logo on the other side.
